# **NOTICE OF PUBLIC HEARING FALLS COUNTY APPRAISAL DISTRICT BUDGET**

The Falls County Appraisal District will hold a public hearing on the proposed Budget for the 2023 fiscal year.

The public hearing will be held on August 25, 2022 at 8:30 A.M. A summary of the appraisal budget is as follows:

- The total amount of the proposed budget is \$784,725.00
- The total amount of the increase over the current year's budget is \$143.00.
- The number of employees compensated under the proposed budget will be 8.5 (full time equivalent).
- The number of employees compensated under the current Budget is 7.5.

The appraisal district is supported solely by payments from the local taxing units served by the appraisal district.

If approved by the appraisal district board of directors at the public hearing, this proposed budget will take effect automatically unless disapproved by the governing bodies of the county, school districts, cities and towns served by the appraisal district.

A copy of the proposed budget is available for public inspection in the office of each of those governing bodies. A copy is also available for public inspection at the appraisal district office.
